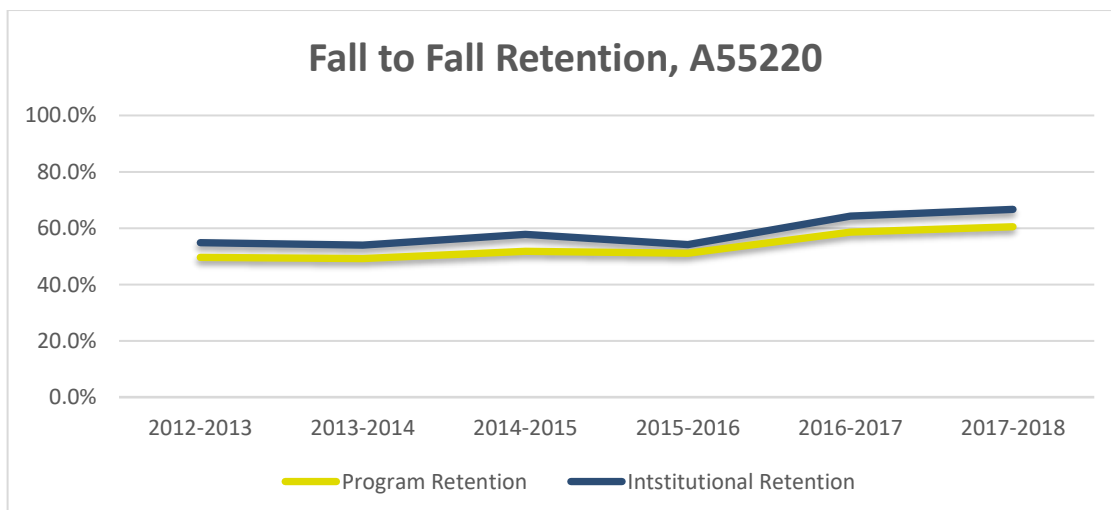

1	Develop a portfolio with detailed information to ECE students regarding their educational plan to be given to students. This will assist them as they progress through the program with planning goals and for staying on track with completion.	Due to changes in the program due to legislation and the NCCCS Office, we decided to make revisions to the handbook before giving them out.

While the program's enrollment has increased in the past year, it is still significantly lower than two years ago. More online classes have been added to the course of study, as requested by students, but these additions have caused the ECE faculty to really work on transparency in courses and provide more face-to-face conferencing with students to help them gain the skills they need. The faculty will also encourage students to utilize the Achievement Coach that has been assigned to the Department. The enrollment in ECE courses across all 58 community colleges has declined in recent years, but with innovations in the field and requirements now mandated for educators, there should be a shift in the interest of the program. The program's retention has steadily increased over the past several years, though.

Over the past two years, our standard/target has been achieved and exceeded. With this in mind, the program would like to increase the standard to 60% and the target to 62% fall to fall retention. With the lower numbers in enrollment, we believe that the higher percentages need to be adjusted to compensate.
