Completer numbers are tied to enrollment and retention numbers and over the past few years there have been many faculty changes as noted in the 2019-20 program review which has affected overall program numbers. Also, some students were not aware of the certificate program offerings and were not placed in them. These were lost opportunities for students to be completers.

Current new enrollment trends are increasing and suggest no need to adjust standard and target. This cycle seems to be indicative of a downturn in program participation which is currently improving. 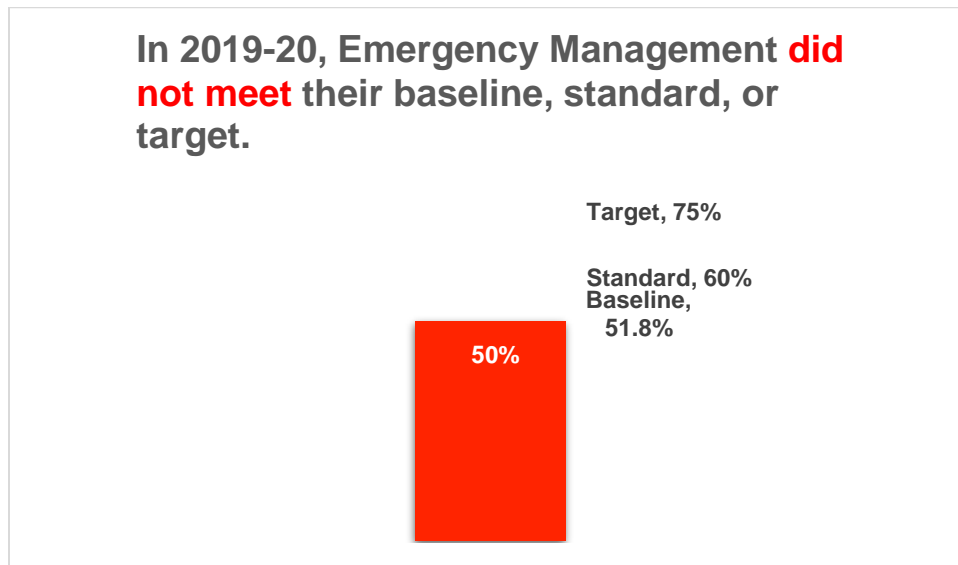

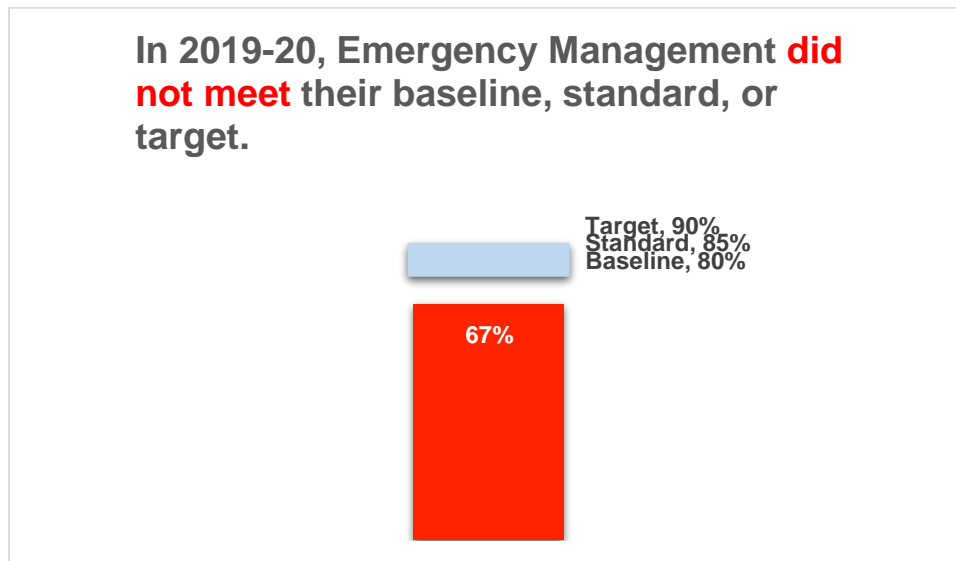

Many students are working professionals or those with delays from high school to college enrollment. This does affect course success. This is however a barrier for our students who are predominantly public safety employees working non-standard work hours. Program offering will continue to be online with support services identified and provided to students.
