



Federal law requires all men 18 years or older and born after December 31, 1959 to register with the Selective Service System to be eligible for federal student aid, unless they meet certain exemptions. The Department of Education was not able to verify your registration or exemption when you completed the FAFSA. *This issue must be resolved before your request for financial aid can be processed.

	I am a non-U.S. male who first entered this country after my 26 th birthday.	Passport with a date of entry stamp, I-94 with date of entry stamp or a letter from the U.S. Citizenship and Immigration Services (USCIS) indicating the date you entered the U.S.

I am a non-U.S. male in this country on a valid non-immigrant visa.	Copy of your I-20 form OR a letter from a school you attended on an F-1 Student Visa indicating your full-time attendance as a non-immigrant alien.
I am a citizen of the Federal States of Micronesia, or the Republic of the Marshall Islands, or the Republic of Palau and have not lived in the U.S. for more than one year for any reason except as a student or employee of the government of my homeland.	Copy of your unexpired passport
